Thank you for your interest No Resolutions Festival. We have chosen a beautiful 80+ acre venue to host our event on the Santa Fe River. We are expecting anywhere between 2500 to 4000 guests to join in on the festivities. We want all of our vendors to be successful and will do our best to ensure that we do not duplicate merchandise to be sold.

The merchandise vendor fee is \$600 and includes a 10x10 booth space, each individual 10x10 spot needed will be available at the cost of an additional booth cost. The designated booth setup site will also be your campsite if desired. Otherwise, primitive camping is also available to you. The fee is good for a 2 person staff. If additional staff is needed, each person must pay an additional \$125. Primitive camping is available to them at that price.

Vendors are requested to be set up and open for display by 9:00am on Thursday. Location is at the vendor coordinator's discretion. Friday & Saturday, artists are asked to have their booth set up for exhibit during peak festival hours. Sunday, vendors may pack at their discretion.

No Resolutions Festival has the right to request any vendor to remove any offensive merchandise.

Vendors may leave displays up overnight however; No Resolutions Festival or Ellie Rays will not be liable for any loss or damages from any occurring circumstance. The security and protection of your exhibit area and your art or craft is your sole responsibility.

Vendors are responsible to collect and report sales tax according to law on any items sold.
